Disclaimer

- > The participant declares to be able to ride his motorbike and master the basics, which presupposes driving on the racetrack.
- > The participant declares to be in good health and in possession of his full physical and mental ability. He states that no medical contraindication prevents him from practicing motorcycling on the racetrack and he is not currently undergoing any treatment that interferes with his abilities.
- > The participant agrees to be fully aware of the accident risk of material and / or body when driving on the race track. He agrees to take this risk and accepts the risk that may arise from other users of the race track.
- > The participant shall bear the sole civil and criminal responsibility for all damage caused by him or by the vehicle used by him, unless a disclaimer is agreed. In the case of caused damage to the infrastructures and the equipment used by the racetrack (according to the internal regulations of the circuit), the participant agrees to pay the resulting costs without delay.
- > The participant agrees with the submission of its application to waive any claim of any kind for damages arising in connection with the event, against the organizer, the marshals, medical personnel and circuit owners, sponsors, racing services and any other person involved with the organization of the event, including their agents and assistants. As well as against other participants (drivers or passengers), their assistants, the owners or keepers of other vehicles.
- > The participant is liable to the organizer for the exclusive use of the vehicle (s) registered by him / her.
- > FVPmoto cannot be held responsible for the thefts committed during the event.
- > This disclaimer of liability does not apply to damages resulting from injury to life, limb or health, which are based on an intentional or negligent breach of duty - even of a legal representative or a vicarious agent of the released group of persons - and not for other damages which are based on intentional or gross negligent breach of duty - even a legal representative or a vicarious agent of the released group of persons.
- > The participant is responsible for his / her own insurance cover (eg vehicle insurance, race track and private liability, health insurance).
- > * For underage participants the written consent of the legal representative is unavoidable.

Protective clothing / technical regulations / rules of conduct

- > The pilot is obliged to wear for race track suitable protective clothing - homologated full-face helmet, leather suit (one-piece or jacket and trousers connected by a waist zipper), leather boots and gloves in good condition, in accordance with the regulations of the back protector.
 - > The motorcycle must be suitable for driving on the racetrack and in perfect technical condition.
 - > Blinker, mirrors, suitcases, license plates and other protruding parts on the vehicle must be removed by the participant before the start of the event - before the technical inspection. Sharp edges are not allowed.
 - > The headlamp, rear and brake lights must be covered with opaque tape.
 - > Exhaust systems are free; the driving noise must not exceed the applicable limit for the respective racetrack.
 - > The assigned number is to be attached to the vehicle, in front and clearly visible.
 - > The participant is obliged to attend the briefings.
 - > During the entire event, the participant must obey the instructions of the FVPmoto employees and the track operator and behave in such a way that it does not endanger other participants in any way.
 - > In the paddock and in the pits, you have to keep pace with every vehicle.
 - > Voluntary stopping on the track, for whatever reason, is strictly prohibited.
 - > On the track, participants of different speeds can meet, special care and mutual consideration is required.
 - > Throughout the event, it is strictly forbidden to drive under influence of drugs or drive-impairing medicaments or under the influence of alcohol (0.0 ‰).
 - > The participant knows that recordings of his person are stored and processed by computerized security surveillance cameras and, if necessary, used to investigate criminal behavior, accidents, damage and / or other similar incidents.
- Following these instructions for equipment, the technical regulations and the rules of conduct is essential for safety. In case of violations, FVPmoto is entitled, without further warning, to exclude the participant from participation in the event, without any entitlement to a refund or reduction of the participation fee.
